Decision of the European Banking Authority appointing the members of the Banking Stakeholder Group

The Board of Supervisors of the European Banking Authority

Having regard to Regulation (EU) No 1093/2010 of the European Parliament and of the Council of 24 November 2010 establishing a European Supervisory Authority (European Banking Authority), amending Decision No 716/2009/EC and repealing Commission Decision 2009/78/EC¹ (the 'Regulation' and 'the EBA'), in particular Article 37.

Whereas:

- (1) The Banking Stakeholder Group ('BSG') shall be composed of thirty members representing in balance proportions credit and investment institutions operating in the Union, their employees' representatives as well as consumers, users of banking services and representatives of SMEs. At least five of its members shall be independent top-ranking academics, while out of its ten members representing financial institutions three shall represent cooperative and savings banks.
- (2) The BSG was initially established on 12th March 2011 and renewed on 15th October 2013 after two-and-a-half years. In July 2015, the EBA modified its policy regarding the appointment of the BSG members with a view to better aligning its practices with the provisions of the EBA Regulation so as to ensure that all the BSG members are able to serve effectively for a period of two-and-a-half years.
- (3) On 12th March 2018, the EBA issued a Call for expression of interest regarding the setting up of the BSG. The deadline for receipt of applications was 7th June 2018, whereby 103 applications for BSG membership were received.
- (4) The Board of Supervisors approved the appointment of the 23 new BSG members at its meeting on 18th September 2018.

Has decided as follows:

Article 1

1. The individuals whose names appear in Annex I of the present Decision are appointed as members of the EBA's BSG and their term of office shall be for the duration of two-and-a-half years, commencing from 18th October 2018.

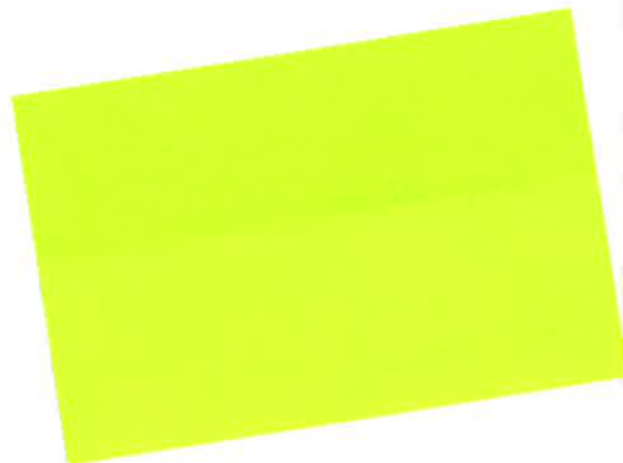
Article 2
